Terms of Agreement:

- *Fees for Shelter Reservations are **non refundable**. *Must be 21 or older to reserve.
- *Reservation transaction must be completed at least 72 hrs prior to Reservation date/time when reserving online. Reservations not within this guideline must be coordinated directly with Parks & Recreation Office Staff.
- *Shelters are not officially reserved until payment in full has been received and paid receipt is issued.
- *I understand that this Reservation Agreement grants me exclusive use of the picnic shelter for the duration of the period in this Agreement. I understand that other Facilities in the Park such as playgrounds, ballfields, tennis courts etc. are open to the general public for use and are not reserved per this Agreement.
- *I understand that I am responsible for the cleaning of the Shelter and disposing of all garbage into containers on site. Failure to comply can result in the assessment of additional maintenance fee's.
- *No alcohol is permitted in the Parks. *No inflatables are allowed/permitted.
- *Solicitation of funds or activities that solicit funds are strictly forbidden in the Parks.
- *No personal grills, tents, etc. are allowed unless a Special Use Agreement is approved in advance.
